




Final design

Guatemala is best known for its volcanic landscape,fascinating Mayan culture and the colorful colonial city ofAntigua.My vision for the mural is to depict the natural landscape and colorful plants such as vibrant hibiscus,graceful gerbera flowers and the tall elegant calla lilies in the fore- ground.I would also like to include the country's symbolic bird;the Resplendent quetzals which are also known as Guatemalan quetzals.

This will represent freedom,self-expression,integrity,and progression. The background depicts La Feria de Barriletes Gigantes, (the Festival of the Giant Kites). The handmade kites fly in the sky to honor loved ones and the departed. The hills are layered with patterns similar to the Mayan textile designs that are seen in many weaving traditions native to the country.
