Prior to calling the meeting to order, Chair Billy Sharp stated he takes full responsibility for the cancellation of the September 12th meeting, citing some members of the board were having technical difficulties with the equipment in viewing the cases and that he didn't know at the time how many people would make the meeting. There was dialog between Chair Sharp and Board Member Hardy when Chair Sharp stated that Member Hardy was out of line with her questioning if the information Chair Sharp was sharing regarding the cancelled meeting was accurate. Member Hardy stated that the meeting was not a re-scheduled meeting, but in fact a meeting that was voted on as an additional meeting to catch up on the back-log of cases. Legal Counsel Chris Heltzel, when questioned stated that the Chair has the authority under board rules to unilaterally set the date and time of special meetings for the business of the board. Member Hardy stated that the board voted to have this meeting prior to Chair Sharp cancelling the September 12th meeting to catch up on cases that were behind because of COVID and various other reasons. Chair Sharp stated that this meeting was in fact already scheduled, but as a virtual meeting to catch up on the back log of cases. Member Hardy's concern is that the board is not being truthful because the website states that the meeting was rescheduled when it was in fact cancelled. In regards to Mrs. Toth stating that officers were homophobic, Board member Chenoa Miller stated that the officers didn't know Mrs. Toth's sexual orientation or who she was married to prior to their arrival on the scene. Board members believe that Sgt. Varga was unprofessional when he stated to the complainant they "we're not the Toth police". The preponderance of the evidence to include the complainant's testimony, officer interviews and WCS footage indicates Sgt. Varga was unprofessional in his tone.

Chair Billy Sharp and board members Chenoa Miller and Ken Mountcastle are attending from the CPRB. Board member Sherall Hardy states that she looked on the website and that this conference is very expensive. She wants to be assured that information is brought back by those in attendance from the conference because she feels that the board needs additional training for those that won't be able to attend. Administrator Perez states that they met with CSU professors in order to break down the Fourth Amendment and those things that the law department can come in and actually train.
