WHEREAS, under Ordinance No. 2076-76 passed October 25, 1976, the City is conducting a Land Reutilization Program ("Program") according to the provisions of Chapter 5722 of the Ohio Revised Code; and

WHEREAS, under the Program, the City has acquired various parcels of real property; and

WHEREAS, Section 183.021 of the Codified Ordinances of Cleveland, Ohio, 1976 authorizes the Commissioner of Purchases and Supplies, when directed by the Director of Community Development and when certain specified conditions have been met, to sell City of Cleveland Land Reutilization Program parcels; and

WHEREAS, the Old Brooklyn Community Development Corporation has proposed to the City to purchase the 6 parcels identified by Permanent Parcel Nos. 009-24-094, 011-03-036, 011-03-038, 011-03-173, 011-04-066 and 011-10-001 and street address South Meadow Ln., Tampa Ave., 3014 Tampa Ave., 3318 Natchez Ave., 3004 Ruby Ave. and 3103 Tampa Ave., respectively, for a single family infill housing use development project; and

WHEREAS, the following conditions exist:

- 1. The members of Council from Wards 12 and 13 has either approved the proposed sale or has not disapproved or requested a hold of the proposed sale within 45 days of notification of it;
- 2. The proposed purchaser of the parcels is neither tax delinquent nor in violation of the Building and Housing Code; now, therefore,

BE IT RESOLVED BY THE BOARD OF CONTROL OF THE CITY OF CLEVELAND that under Section 183.021 of the Codified Ordinances of Cleveland, Ohio, 1976, the Commissioner of Purchases and Supplies is authorized, when directed by the Director of Community Development, and the Mayor is requested, to execute one or more Official Deeds for and on behalf of the City of Cleveland, to the Old Brooklyn Community Development Corporation, for the sale and development of Permanent Parcel Nos. 009-24-094, 011-03-036, 011-03-038, 011-03-173, 011-04-066 and 011-10-001 respectively located at South Meadow Ln., Tampa Ave., 3014 Tampa Ave., 3318 Natchez Ave., 3004 Ruby Ave. and 3103 Tampa Ave., according to the City of Cleveland Land Reutilization Program in such manner as best carries out the intent of the program.
