1. Gerald Meyer called the meeting to order at 3:10 p.m.
2. Gerald Meyer called for a motion to approve the minutes of December 5, 2001. Patrick Gallagher made a motion to approve the minutes, the motion was seconded by Kathryn Jackson and approved by the Board.

Window Washing is not covered by law because company is a for-profit, less than 20 employees, Hillcrest Foods-covered employer, compliance forms on file, Tom Paige-covered employer, compliance forms on file, Cyniger, not covered employer because company is a for-profit, less than 20 employees.
