1. Gerald Meyer called the meeting to order at 3:10 p.m.

3. Old Business:

- Service Contract Report 2002 was reviewed. Tanya will make corrections to the report and update report to include additional contractors.
- Financial Assistance Report 2002 was reviewed. Tanya will make corrections to the report and update report to include additional financial assistance recipients.
- Gerald Meyer suggested that an additional column be added to the reports to reflect if the FEWB notice was sent to Covered Employers.

- Ameritemps is unwilling to hand over additional payroll records. The City's Law Department is investigating.
- Angela Caldwell provided recommendations for revising the Fair Employment Wage Law. Additional recommendations will be made later in the year by the Board.

New Business:

- Companies applying for exemptions: Kevin Schmotzer, Manager of Business & Retention presented information regarding companies seeking exemptions. To date, only one company has applied for an exemption, Cleveland Tool & Die.
- Companies the City has not been able to assist because of the Law: Kevin Schmotzer presented information regarding companies the City has been unable to assist because of the law. The companies are Midwest Presort Mailing Service, Mr. Heater, and Crawford Container.
- Angela Caldwell wanted information regarding the Vacant Lot program. She wanted to find out if the employees working for this program are being paid the Fair Employment Wage rate. This program is administered through Parks and Recreation. The service contractors awarded the contract, Flex-Tech and Northcoast Employee Leasing, hire the employees working for this program. Under this service contract, the contractors must pay their employees the Fair Employment Wage Rate.
