1. Bassett: Is power for the FAA light to come from the brick electrical building? If so please advise if there is existing buried conduit between the tower and the electrical building. Also, please advise if the empty carrier pipes on the exterior of the tank can be used as the conduit.

Answer: The power is coming from the electrical building, there is already a breaker for the FAA light. If needed the carrier pipe can be used.
