i.e. Item 16 f. Boom Lifts – the size range listed may need to be separate pieces of equipment. If you have an alternate item (s) to suggest list the item (s) and enter the rental prices.

Q: Is it a single award contract? Are all units required to bid on or any able to supply?

A: Per Section C-7 Method of Award, C-7 A and C-7 B, one contract will be issued, all items must be bid.

Q: What is the amount of the bid bond required?

A: Per Instructions to Bidders A-4 and Section C-2 City Forms, A-2 a bond of at least 5% of the bid total is required.
