

#### **Answers and questions received:**

1. Can we get bid results from the last bid?

Answer: Current prices:

1A - \$ 1.41/lb.

2B – \$1.58/lb.

1C - \$1.79/lb.

2. Will the City allow proposals for 2 or more alternative products?

Answer: Yes, more than one bid/sample may be submitted. Each sample will require a separate bid. If bidding 2 different items, 2 bid packages must be submitted with all required documents.

3. Do you currently have railroad access to your facility?

Answer: No railroad access at the facilities.

4. Is the PAC unloaded into a silo or a slurry tank?

Answer: We have both types of storage. Tanks at 3 plants and a silo at Crown.
