Answers to questions received:

1. Will all three tanks need to be cleaned?

Answer: All four tanks/towers (Independence Tank, Darrow Tower, Ledge Tower and Brecksville Tower) will be cleaned by the Contractor. Darrow Tower, Ledge Tower and Brecksville Tower will be disinfected by the Contractor. Cleveland Water (CWD) will disinfect Independence Tank.

2. How are line items 9 and 10 computed on the Bid – Schedule of Items page?

Answer: Line items 9 and 10 of the Bid – Schedule of Items page is set as allowances. These amounts have been pre-determined in the event we should need the services during the term of the contract. You will add line items 9 and 10 total to your bid total.

3. When we submit questions to the Division of Purchases and Supplies will the questions be answered within 24 hours?
