General Information

You must submit the following items for a complete ROW Contractor Registration application to be reviewed:

- 1. Application Form
- 2. Bond
- 3. Certificate of Insurance
- 4. Check for \$100 made payable to City of Cleveland

Application form:	Please complete the application form. Do not leave any spaces blank. Application must be signed by the applicant, who must be an officer or legal signee of the company.
Bond Form:	The applicant must submit a performance bond of the amount that would cost to perform the work being performed within the public right of way or submit an umbrella bond in the amount of two hundred fifty thousand dollars (\$250,000.00). Any person providing an umbrella bond will be deemed to have met the performance bond requirements of this section for the duration of the performance bond.
2) 3)	a minimum coverage of \$200,000 is required:

Insurance Endorsement:	If your insurance agent is not authorized by the insurance company to delete the words in the cancellation clause, have them complete the enclosed endorsement sheet and attach it to the certificate of insurance.



Revocation of the ROW Contractor Registration:

This ROW Contractor registration may be revoked by the City of Cleveland if either three occurrences for the following reasons happens during a 365-day time period or the holder performed such an egregious action that the City determines that the said contractor should not work within the public right of way:

- The holder is convicted of a misdemeanor involving moral turpitude or a felony during the renewal period of that Certificate of Registration
- The holder obtained a Certificate of Registration by fraud, misrepresentation or deception
- The holder engaged in fraud, misrepresentation or deception in the conduct of business
- The holder no longer has a valid policy for the required insurance or bond
- The holder used its Certificate of Registration to obtain a permit for another entity
- The holder repeatedly failed to secure permits, inspections, and approvals required under Chapter 503
- The holder repeatedly installed work in an unworkmanlike manner as defined by the Construction Standards and Specifications of the City of Cleveland or not in conformity with permits issued by the City;
- The holder does not provide restoration to work performed as stated by the Construction Standards and Specifications of the City of Cleveland.
- The holder has received written or verbal notifications of violating Construction Standards and Specifications of the City of Cleveland and has failed remedy such violations; and
- There have been repeated incidents of returned checks for insufficient funds or stop payment without just cause involving the payment of right of way permits.

Stop Work Orders:

The City may issue a Stop Work Order if work is being performed without a valid permit or for the following reasons:

- The work unreasonably interferes with the performance of work by another party who received a City permit before the issuance of permittee's permit; or
- The suspension of the work is necessary for the City to evaluate, prevent, or address a hazard or risk to the health, safety, and welfare of the public; or
- The work performed, or the work being performed, is not within the scope of the work approved by the permit; or
- The work is creating, or has created, unsafe work conditions; or
- The permittee or his or her agent fails to abide by the provisions of these Codified Ordinances; or
- The permittee or his or her agent has violated the conditions of or the rules and regulations governing the permit; or
- The work performed, or the work being performed, fails to comply with the City's specifications and standards.

A permittee whose permit is suspended may appeal to the Board of Right-of-Way Appeals, in writing, within ten (10) days of the City's decision. The City may revoke a street opening permit at any time if the permittee fails to comply with the requirements contained in a Stop Work Order or any law, rule, or regulation relating to the performance of work in the public right-of-way or if permittee's, or its agent's, Right-of-Way Registration is revoked.



If a street opening permit is suspended, the permittee shall discontinue any work and shall not commence work until the City provides written notification lifting the suspension. If a street opening permit is revoked, a new permit shall be secured before any further work may proceed.

Emergency Permits:

In an emergency, a person may make an excavation or opening or remove pavement in any highway, lane, road, street or alley of the City, provided that the person notifies the ROW Permitting and Enforcement section in writing of the emergency, including a description of the nature of the emergency, and applies for a street opening permit within seven (7) calendar days of making the opening. The appropriate street opening fee shall accompany the application. Any person failing to notify the ROW Permitting and Enforcement section shall be charged the regular permit fee plus an additional fee of two hundred dollars (\$200.00) to cover the City's administrative costs of identifying and inspecting the street opening made without a permit.

Other Items:

The street opening permit shall identify the time period in which the street opening must be closed. If the work is not started within the time designated in the street opening permit, the permit may be revoked by the City. If the work has been started but not completed within the time designated in the street opening permit, the permit may be revoked by the City. If the permit is revoked, the City may charge all accrued restoration charges to the permittee. Should the permittee fail to pay all accrued restoration charges within thirty (30) calendar days of receipt of notice, the City may draw, from the permittee's performance bond, funds sufficient to restore the highway, lane, road, street, or alley.

A permittee, in accepting and acting under a street opening permit, agrees to assume full responsibility for injury and damage to persons and property incurred because of any settlement of a restored area, and further agrees to pay all costs involved in reconditioning such areas. If any settlement in a restored area occurs within a period of one (1) year from date of completion of the permanent restoration, it shall be considered as conclusive evidence of defective backfilling. Any expense incurred by the City in correcting such settlement shall be paid by the permittee.

Please remember that if you are performing work within the public right of way, you need to be registered as a ROW contractor. You do not need to be registered as a ROW contractor if:

- You are a public utility company who is performing your own work. If you are a contractor for a utility company or a private utility performing your own work, you must register.
- If you work directly for the City of Cleveland (you are an employee of Cleveland) you do not need to register. If you are a contractor for the City of Cleveland, you must register.



FAQ

- 1) Is it possible for me to have my ability to work in the ROW of Cleveland revoked after one enforcement action by the City?
 - a. Yes. For instance, if you did not receive a permit for your ROW work, did not call for an inspection of your work, and are performing work that is not per City standards, you would receive a "ROW violation" for each of these. Since it would add up to three (3) violations inside of 365 days, your ROW contractor registration would be revoked. You would not be allowed to perform any work within the ROW until your ROW contractor registration is reinstated.
- 2) If I'm already a registered contractor via Building and Housing, do I still need to register as a ROW Contractor?
 - a. Yes. Regardless of being registered via Building and Housing, you cannot perform work within the public ROW unless you are a registered ROW contractor after 7/1/2025.
- 3) Where do I send the ROW contractor registration application form and payment to?

- 4) If I am just obstructing the public ROW, do I need to be a registered ROW Contractor?
 - a. It depends. If you are an entity that is obstructing the public right of way for an event, block party, dumpster, then no, you do not need to be registered. If you will be penetrating the ground in any way within the ROW, unless you work directly for the City of Cleveland or a public utility, you will definitely need to be registered as a ROW contractor. If you are a contractor for a private utility or a private utility performing work in the ROW, even if it is not penetrating the ground, then you will need to be a registered ROW contractor. - 5) If I am working on private property, do I need a ROW permit and be a registered ROW contractor?
 - a. If you are working on private property, but will be obstructing any part of the ROW for materials or vehicles, you will need a ROW obstruction permit. If all you are doing is obstructing the ROW for materials or vehicles, you will not need to be a registered ROW Contractor. Example: if you are a plumber and you are fixing the sanitary lateral from the house to the clean out which is on private property, but you need to have some equipment on the sidewalk when performing the work, you would not need to be a registered ROW contractor, but would need a ROW obstruction permit. If during this work, you damage the sidewalk, to have it repaired, you would either need to be a registered ROW contractor repair the sidewalk.
- 6) If I have a contract to perform work within the public ROW with an entity (CWD, CPP, CEI, WPC, etc) and my ROW contractor registration is revoked, can I still perform by contractual duties within the public ROW for that entity?
 - a. You would not be allowed to perform any work, regardless of existing contracts, within the public ROW and are subject to any fines and/or punishment stated for violation of the City of Cleveland Codified Ordinance 503.
