Antonio Muñiz, #440 <i>Allegation A: Lack of Service:</i> Chief Issued Dismissal Letter: The Chief found that upon arrival, neither Officer Brooks nor Officer Muñiz observed the child unattended in the vehicle. The child was already with the mother, and the parents stated the child had only been left alone for approximately five minutes, conflicting with witness statements of twenty minutes. A supervisor, Sergeant Vowell, who had prior experience in the Sex Crimes and Child Abuse Unit responded, assessed the child’s condition, and determined there was insufficient evidence to pursue charges under ORC 2919.22 or CCO 609.01. Because a supervisor assessed the scene and reasonably determined no report was required.</p> <p>Sgt. Dustin Vowell, #9323 <i>Allegation A: Lack of Service:</i> Chief Issued Dismissal Letter: The Chief found that Sergeant Vowell responded to the scene, spoke with the mother, and learned the child had been left unattended for approximately five minutes. He assessed the child’s condition, found the child to be in good health, and determined—based on his prior experience in the Sex Crimes and Child Abuse Unit, that there was insufficient evidence to pursue charges under ORC 2919.22 or CCO 609.01. He ensured the child left the scene properly secured in a car seat.</p>
