While still in the parking lot, she made several accusations that Patrol Officer Robles was a "racist bastard." Sergeant Daniel Day responded to the scene and was briefed by Patrol Officer Robles, and then Sergeant Day conferred with the complainant. Upon gathering information and observing the behavior of the complainant Sergeant Daniel Day authorized the Disorderly Conduct citation, as evident by his explaining the ramifications of not signing the citation. Because the on-scene supervisor approved the merits of the citation, I am
