The CPRB asserts that on April 13, 2023, you, Patrol Officer Carlos Robles #2283, improperly issued a citation to Ms. Alexander for disorderly conduct, violating Ohio Revised Code 2917.11: Disorderly Conduct. (Group I Violation)	Date Heard by Chief: 07/09/2025  P.O. Carlos Robles #2283 Allegation: Improper Procedure: Citation Chief's Departure Recommendation: Dismissed The complainant was parked illegally in a handicapped parking spot at a busy shopping center. While in this shopping center parking lot, she did call Patrol Officer Robles an "ass-hole." The complainant then requested a supervisor respond to the scene. While still in the parking lot, she made several accusations that Patrol Officer Robles was a "racist bastard." Sergeant Daniel Day responded to the scene and was briefed by Patrol Officer Robles, and then Sergeant Day conferred with the complainant. Upon gathering information and observing the behavior of the complainant Sergeant Daniel Day authorized the Disorderly Conduct citation, as evident by his explaining the ramifications of not signing the citation. Because the on-scene supervisor approved the merits of the citation, I am departing from the Civilian Police Review Board's recommendation for

The CPRB asserts that on or about April 8, 2024, you, Patrol Officer Kyle Paridon #938, posted in a Facebook group an image of yourself in a Cleveland Division of Police uniform next to two zone cars, pointing at the sky with your firearm while wearing eclipse blocking glasses, which invited racially insensitive comments to the group. The CPRB specifically pointed to the subsequent social media post in the group concerning an acorn falling, which was a reference to a news story about a white officer who claimed he had mistaken an acorn falling for a gunshot when he fired repeatedly at a black male suspect, violating Manual of Rules 5.01 (Group III Violation).
