However, she noted that Janusczak was not the primary officer but assisting in a chaotic scene while guarding a suspect. His directive for the complainant to return across the street, including the statement about handcuffs, was determined to more closely comport with a Group I violation rather than Group II. Accordingly, the Chief departed from the CPRB's recommendation, merged the two specifications into a single Group I violation, and recommended a Written Reprimand as set forth in the charge letter.
