OPS2022-0185 Complainant: Hawkins (Present)

Presented by: Investigator Green

Allegation A: Unprofessional Behavior/Conduct Allegation B: Lack of Service: Insufficient Service

**Summary of Case Presentation**: Ms. Hawkins called for a wellness check on her father. It took officer three hours to respond. She alleged P.O. White was rude when contacting her. It was noted that the call to service originated out of Shake Heights and then transferred to Cleveland.

Board Discussion Summary: Member Gatian asks Investigator Green if the phone number Ms. Hawkins provided did belong to P.O. White. Investigator Green confirmed it's P.O. White's work cell and the calls were noted in his report. Chair Brown asks if the neighbors/witnesses were interviewed. Investigator Green advised WCS footage shows police interaction with the neighbors and checking with maintenance. Chair Brown asked about police procedure for wellness check response time. Investigator Green informed it was classified as a priority 2 call and there were other calls at the same time. Member Gatian asked if the complainants have full access to the investigative report. Interim Admin. Traxler advised they can make a public records request, but information will be reducted.



Additional Information to Note: Ms. Hawkins was present. She stated officers mocked her and are robbers in cop uniforms and do not deserve the badge. Ms. Hawkins claimed the officers robbed her from the last minutes with her dad. Chair Brown asked if the officers were unprofessional with neighbors. Investigator Green informed the complainant she can complete a public records request to retrieve the documents from the case. Chair Brown informed that identifying information and visuals of deceased individuals is typically redacted/censored for public viewing. Asst. Director of Law Hall informed Ms. Hawkins she can provide her with a phone number. Member Cyganovich advised Ms. Hawkins that EMS was the one to pronounce her father's death, not the police. Ms. Hawkins asks if the board thinks it's okay for an officer to say "Hey, come get this body. We ain't trying to be here all day." Chair Brown said that it is not professional and asks if there is anything else Ms. Hawkins wants to add to her complaint. Ms. Hawkins stated the officers are overworked and inquired if there is anything the board can do. Chair Brown acknowledged that struggle and suggested Ms. Hawkins reach out to the CPC to present that issue as it is outside of the CPRB's purview. Member Miller advised the complainant that cases are reviewed with sensitivity to the complainant and gave her condolences.

Case was discussed at last CPRB meeting (August 12<sup>th</sup>, 2025). Chair Brown provided the reminder that Specification #7, an allegation of Unprofessional Behavior/Misconduct be SUSTAINED. Board asserted that on or about April 8, 2024, P.O. Kyle Paridon, #983, posted in a Facebook group an image of himself in a CDP uniform, next to two zone cars pointing at the sky with his firearm while wearing eclipse blocking glass, which invited racially insensitive comments to the Facebook group. The CPRB specifically pointed out the subsequent social media posts within the group concerning an acorn falling, which was a reference to a news story about a white officer who claimed he had mistaken an acorn falling for a gunshot when he fired repeatedly at a black male suspect, in violation of Manual Rule 5.01. The board classified this as a Group Three violation. The Public Safety Director's Departure stated the following, "The Facebook post noted in Specification #7 contains insufficient evidence to support a determination that you invited racially insensitive comments. Therefore, I depart from the Civilian Police Review Board's finding for Specification #7 and as such, I "Dismiss" Specification #7."

Motion made that the CPRB does not accept with the Public Safety Director's finding of departure and move forward with original finding of SUSTAINED for Specification #7, as the Public Safety Director did not provide clear and convincing evidence to change the board's original finding.

OPS2024-0130 Complainant: Anonymous

**Investigator: Art Bowker** 

CPRB heard this case on June 10, 2025, and **SUSTAINED** two allegations (Specification #7: Unprofessional Behavior/Conduct and Specification #9: Improper Procedure) against **P.O. Demetrius Woods**, #2127.

Case heard by the Chief on July 28, 2025. Chief recommended **Specification #7** be dismissed per GPO 5.12.06. which explicitly states, "officers on an Executive Protection Detail shall be exempt from wearing the Wearable Camera System". She also recommended **Specification #9** be dismissed as there is no date on EAC-1 to indicate when the form was submitted as part of this crash investigation, there is insufficient evidence to find that it was submitted late and outside of policy.

Specification #7: Chair Brown asks Investigator Bowker is he as looked over the GPO brought up by the Chief. Investigator Bowker informed OPS and CDP were both unaware of this GPO. Member Gatian asked how it was missed. Investigator Bowker advised OPS does not get live updates on GPOs as they did previously and noted that CDP was not aware of the GPO either. Member Sharp pointed out that is case is an example of clear and convincing evidence. Member Miller stated that it is concerning that OPS was not aware of the CDP. Investigator Bowker once again stated OPS conferred with CDP and they were also unaware. Member Miller inquired as to what could facilitate this confusion. Senior Investigator Funari added there have been issues with SharePoint. Interim Administrator Traxler advised she talked to the administrator of CDP's SharePoint and OPS was dropped from their SharePoint during their transition.

Motion made to accept the Chief's departure on specification, <u>as the Chief provided clear and convincing evidence through a GPO that the board was previously uninformed of at the disposition of the determination.</u>

**Specification #9:** Investigator Bowker confirmed it was not submitted immediately, as required by the GPO, and was submitted approximately a month later. Investigator Bowker advised that



he informed the Chief how OPS and CPRB how reach the conclusion. GPO states the report should be submitted immediately.

Motion to proceed with original finding of **SUSTAINED** in that the Chief did not provide clear and convincing evidence. The Chief's assertion that simply because there was no space for a date and there was no date on the form does not meet the level of clear and convincing evidence.

OPS2023-0140 Complainant: Lars St. John

Investigator: Investigator Szymanski

CPRB heard this case on August 13, 2024, and **SUSTAINED** an allegation of Unprofessional Behavior/Misconduct against **P.O. Anthony Rice**, #1886. The CPRB asserted that on or about June 7, 2023, P.O. Rice exhibited Unprofessional Behavior/Conduct when displaying a nonverbal sign of being discourteous and rude while interacting with Mr. St. John. Group One violation.

Case heard by the Chief on July 28, 2025. Chief recommended the allegation be dismissed as "The complainant had much of his face covered and Patrol Officer Rice "displayed a non-verbal sign" that he would like the complainant to lower his face covering while they talked. The complainant became upset by this, and Patrol Officer Rice thought it best to de-escalate the situation by having another officer (Patrol Officer Anthony Longer #2452) interview the complainant. Patrol Officer Longer then interviewed the complainant. The "non-verbal sign" of asking someone to lower a facemask does not rise to the level of being discourteous. Also, after the complainant became upset with Patrol Officer Rice, he employed the de-escalation technique of having another officer speak to the complainant."

Chair Brown noted that the board has been working on focusing rationale and making sure those are robust. He further stated this case is an example of written rationale not encompassing the entire rationale that the board went through during the meeting. Chair Brown advised that the behavior P.O. Rice extended was beyond a hand gesture – it included the verbal communication and overall communication with the complainant. Member Cyganovich voiced concern with the Chief focusing on the gesture but did not address the other rudeness that occurred. She thinks the Chief missed it and did not provide clear and convincing evidence that the officer was not rude. Member Gatian agreed that the board's rationale may not have been clear. He further stated the major and discourteous behavior was when the complainant had an exchange



with P.O. Rice in the lobby where P.O. Rice turned his back on the complainant and walked away without communicating. Member Sharp voiced that the board may have put the Chief in a bad spot with the rationale that they supplied.

Senior Investigator Funari informed that the Chief wants more specifics on what behavior is being considered "rude" when presenting. Asst. Director of Law Hall asked to table this matter so the legal department could review the language OPS presented to the Chief and see if it accurately reflects what was said in the CPRB hearing.

Motion to table case until October meeting pending finding out more information on the case so the board can determine if they will accept the Chief's departure, <u>as well as obtain clarification on the board's ability to clarify.</u>

Summary of Case Presentation: OPS reviewed all WCS footage recordings from responding officers. The incident that Mr. Vernet-Vancol alleged took place on November 2, 2022, did **not** occur and the incident was recorded in its entirety using CDP issued WCS. All responding officers used appropriate language, remained professional, and courteous through the encounter with Mr. Vernet-Vancol and his mother per Manual Rules 5.02 and 5.03. The complainant was not placed on the ground, nor was he hit or struck. Responding officers did not draw weapons of any kind. A police report was made for property lost and Mr. Vernet-Vancol was transported by CDP to St. Vincent Hospital for mental health services at the request of his mother.

## **Board Discussion Summary:** N/A

Additional Information to Note: Investigator Green noted the WCS footage of this incident had been deleted due to retention. OPS had the footage at one point, but it was lost when there was a cyber-attack. Investigator Green had previously transcribed the WCS footage, and those transcriptions were included. The allegations against P.O. Stephen Johnson, #305, have been administratively dismissed as P.O. Johnson separated from CDP on December 21, 2023.

Summary of Case Presentation: On November 2, 2024, officers were dispatched to a dispute between Ms. Mccain and political canvassers outside her house. Upon arrival, P.O. Myers, P.O. Longstreet, and Sgt. Hoover attempted to defuse the situation. Ms. Mccain informed P.O. Myers she had doorbell footage of the incident but refused to share it with him because she did not what the help of the police. This interaction was not recorded as P.O. Myers' WCS died earlier in his shift. There is no evidence that P.O. Myers reporting his WCS, thus violating GPO 4.06.04. Ms. Mccain alleged P.O. Myers and Sgt. Hoover failed to provide service, and Sgt. Hoover, specifically, was racially biased against her. WCS footage shows both officers being professional in their interaction. Despite multiple attempts, Ms. Mccain failed to cooperate in giving Sgt. Hoover her information, thus preventing him from filing a report. During the course of the investigation, Ms. Mccain alleged she saw Sgt. Hoover drive past her house the day after the incident. Sgt. Hoover



denied going back to Ms. Mccain's house or retaliating against her when she said she would be filing a complaint with OPS.

**Board Discussion Summary:** Vice Chair Mountcastle asked for clarification. Investigator Watson relayed that P.O. Myers does not remember reporting that his WCS died. She confirmed with Member Sharp that there was no evidence to support P.O. Myers reported his WCS dying. Investigator Watson advises Sgt. Hoover's duty report and that does not indicate P.O. Myers' WCS dying nor did Sgt. Hoover recall is P.O. Myers reported it or not. It was further added that P.O. Myers' last video of the day does not show him telling dispatch his WCS is dying – it just dies.

**Summary of Case Presentation**: Complex case. Mr. Long alleged that on July 23, 2022, the officers pulled him out of his car, hurt his knee, and took him to jail without providing medical attention. He alleged that the officers' actions caused him to have pain throughout his body including his collarbone, knee, shoulder, and a burn mark. The investigation found that Mr. Long was visually impaired, attempted to operate his vehicle, and has outstanding warrants. Officers gave Mr. Long 20 minutes to leave his vehicle, to which he resisted and refused to exit. P.O. Selleny pulled his taser out and arched it at Mr. Long when he refused to comply with lawful commands. Officers used de minimis force to remove Mr. Long from his car. Mr. Long refused EMS service, prior to police arriving on scene. He was later taken to St. Vincent Charity Hospital, where he once again refused medical treatment.

**Board Discussion Summary:** Member Miller asked Investigator Ouk if he was able to get into contact with Mr. Douglas given the severity of the allegations. Investigator Ouk relayed it is an interesting case as Mr. Douglas is banned from the office — Investigator Ouk and Senior Investigator Funari met with him outside to sign a HIPAA form. Mr. Douglas was not interested in providing information to OPS or doing an interview.

The officers denied providing Ms. Drummonds with a ride as they were finishing a report for a domestic violence transport to a safe and secured shelter that they had just completed. There is no radio traffic due to the DV and situation of that case.

Thompson offered Ms. Drummond service by attempting to gather her statement and provided the officers' names and badge numbers. Numerous attempts were made to contact Ms. Drummonds and all of which were unsuccessful.



**Board Discussion Summary:** Member Sharp asked if a second meeting occurred between P.O. Thompson and the complainant. The district was across the street from the gas station, and the complainant was walking down the street as the officer parked – they met inside the lobby to get her side of the story. She became upset when hearing the backstory provided by the gas attended. The lack of service allegation was due to Ms. Drummonds wanting the gas station attendant arrested.

Dust indicated that at no time did they instruct P.O. Doerner to cease communication with Ms. James.

**Board Discussion Summary:** Board asked what the officer's rationale was for not reaching out to the complainant. P.O. Doerner claimed he was told not to contact her, but his supervisors said they never told him to cease communication. Appears as though P.O. Doerner was insubordinate and lying. Discussion as to whether the board could suggest IA look into these matters – decided against making that recommendation.
