ADDENDUM to the Request for Proposal for Police Officer Recruitment Marketing Consultant Services for the Division of Police, Department of Public Safety

Attention: All Interested Vendors

This addendum answers questions received in writing by the City of Cleveland Department of Public Safety.

PART 1. Changes made by this Addendum.

<u>Due Date Extended</u> The due date for responding to this Request for Proposal has been extended. Proposals must be submitted by Friday, December 20, 2024 not later than 5:00 PM EST. Proposals are to be submitted via email to <u>mgehlmann@clevelandohio.gov</u>. The proposals will not be opened until after the deadline on Friday, December 20, 2024.

PART 2. Answers to Questions Received.

We received the following questions and have indicated our responses in **bold** below. Similar questions may have been consolidated into one question.

1. Is the RFP listed on OpenGov?

The RFP is not listed on OpenGov and we are not using this platform for this RFP. Responses should be emailed in accordance with the instructions on p. 2 of the RFP to the email address listed above.

2. What is the budget for this project?

The budget for this project is \$260,000.00. The budget is for the creation of the marketing plan and execution of the advertising campaign by the awarded vendor. The advertising campaign will continue until the funding for this project is exhausted.

3. Does the Division of Police want video production included in this project?

Video production is at the discretion of the proposers. The City is seeking the most effective and impactful advertising campaign within the stated budget.



4. Is a local vendor preferred?

All responses to this RFP will be evaluated based on the criteria indicated on pp. 14 – 15 of the RFP.

5. Are out of state/ foreign agencies eligible to bid on this RFP? Is a local office needed? Does an out of state/ foreign agency need to be registered in the State of Ohio?

Out of state and foreign agencies are eligible to bid on this RFP provided they are authorized to do business in the State of Ohio.

6. Do you have an incumbent and will they be participating in this RFP?

This is a stand-alone project which will be administered by the awarded vendor/agency.

7. Does this project have a subcontracting goal?

Yes. The subcontracting goal for this RFP is 10% Cleveland Small Business. Please see the attached list of certified firms for reference.
