§ 381.05 Permits Required and Approval

- (c) A permit is required to install remove, repair or alter any tank for the storage of hazardous substances. The permit shall contain a general description of the proposed work and shall include two (2) copies of a drawing indicating location, use, capacity and piping arrangement of all existing and proposed tanks located, or which are to be located, upon the premises and all adjacent buildings and property lines.

§ 381.052 Fees for Permits for Storage tanks

- (a) The following fees are hereby established to install, remove, repair or alter tanks for the storage of hazardous substances:
- (4) To remove, abandon, place temporarily out of service or otherwise dispose of a tank. Fee: one hundred fifty dollars (\$150.00).
- (b) The fees established by this section shall include review of the permit application, review of the plans, and the issuance of a permit. The fees established shall also include the presence of a representative of the Division of Fire at the testing of the tank or piping, if applicable, for a single day not exceeding four (4) hours. If the testing extends beyond a single day due to continuation of the acceptance test, failure of the tank or the piping, or any other cause whatsoever, then an additional fee of one hundred fifty dollars (\$150.00) plus fifty dollars (\$50.00) for each additional day shall be paid for the presence of a representative of the Division of Fire at each additional day of testing or fraction of a day. After hours inspection fees shall be based on current overtime rate, minimum of four (4) hours per inspection. (Ord. No. 1144-2024. Passed 11-25-24, eff. 12-3-24)
