1	17-009	Harris	Merritt	Unprofessional Conduct Excessive Force Failure to Arrest/Document	Originally heard by the Board on April 18, 2018. P.O. McMullen #2305 and P.O. Wright #1731 responded to a domestic violence call wherein they identified the Complainant as the primary aggressor. The victim/son asked CDP not to arrest his mother, and they complied with his request. The Board Unfounded the allegations of Unprofessional Conduct and Excessive Force, but Sustained the additional violation of Failure to Arrest/Document, because the General Police Order (GPO) 3.4.16 states, "In instances where a primary physical aggressor can be identified, that person shall be arrested."
