## VII (A). REVIEW OF CHIEF'S DISCIPLINARY DECISIONS

1	19-187	Wilson	Richardfson	Improper Search – the CPRB recommended a <b>Group I</b> discipline level for P.O. Yasenchack #2362's lack of probable cause to search the Complainant's vehicle after he claimed to smell marijuana, and no marijuana was found.	Chief Williams <b>departed</b> from the CPRB recommendation, citing that P.O. Yasenchack determined that a passenger seated in the rear of the vehicle smelled of burnt marijuana, and that the other officers who arrived on scene may not have aware of this reason for probable cause. Chief Williams <b>dismissed</b> the allegation of Improper Search against P.O. Yasenchack.
