McNatt #1551 and P.O. Nagy #1252 for their failure to secure the Complainant's electric bicycle.</p>	<p>Chief Williams <b>concurred</b> with the CPRB recommendation for the allegation of Missing Property, and issued P.O. McNatt a <b>10-day suspension</b> and P.O. Nagy a <b>6-day suspension</b>.</p> <p>Chief Williams <b>departed</b> from CPRB recommendation on the allegation of Lack of Service, citing that the allegations are duplicative of each other, and chose instead to concur on the higher group level of violation.</p>
