Hategan #1879 for his failure to use the half-page, neon orange abandoned vehicle form on the Complainant’s vehicle.	Chief Drummond concurred with the CPRB recommendation and issued P.O. Hategan a Letter of Reinstruction , as well as an order to review the relevant GPO to ensure that it is followed verbatim in the future.
2	20-030	O’Toole	Funari	Improper Procedure – The CPRB recommended a Letter of Reinstruction for Dispatcher Randolph #124 for her failure to correctly record the Pennsylvania license plate of the Complainant’s towed vehicle, leaving it as an Ohio plate, causing a delay in locating and releasing the Complainant’s vehicle from the impound lot.	Chief Drummond concurred with the CPRB recommendation and issued Dispatcher Randolph a Letter of Reinstruction .
3	21-111	Curiale	Delaney	Lack of Service – the CPRB recommended a Letter of Reinstruction for P.O. Smith #2117 and P.O. Bliss #29 for their failure to generate a report documenting the mental male’s presence at the Complainant’s store, and; Unprofessional Conduct - the CPRB recommended a Group I category for Dispatcher Taylor #120 when she told the Complainant that officers “have to drive there – they don’t just fall out of the sky – they have to drive there,” as the Complainant expressed concern that police had not arrived and she was concerned for her safety.	Chief Drummond concurred with the CPRB recommendation and issued both P.O. Smith and P.O. Bliss a Letter of Reinstruction . Dispatcher Taylor departed from CDP service on November 12, 2021, and therefore discipline cannot be imposed on her.

Orozco #1601 and the derogatory comments made about the Complainant to the Complainant's neighbor during a call for service.</p>	<p>Chief Drummond departed from the CPRB recommendation and dismissed the allegation, citing that P.O. Orozco's conversation with the Complainant's neighbor was not in the presence of the neighbor and was de-escalating in nature – building rapport to assist with handling the assignment, as P.O. Orozco's statement was based on knowledge gained from previous assignments.</p>
5	21-204	Curbelo	Harris	<p>WCS Violation – The CPRB recommended a Group I category for P.O. Davis #561 and his failure to activate his WCS during his encounter with the Complainant when she approached him after receiving a parking citation.</p>	<p>Chief Drummond concurred with the CPRB recommendation and issued P.O. Davis a written reprimand as well as an order to re-read GPO 4.06.04 and be instructed by a superior officer on that Order.</p>
