Williams #1586's allegation of Unprofessional Conduct, citing he told the complainant to stop speaking and that this would not be the last encounter her African American sons had with police.</p> <p>Chief Williams <b>dismissed</b> the allegation, citing that P.O. Williams was acting as a mentor when he made the statements he did.</p> <p>The CPRB voted to appeal this decision to the Director and <b>amended</b> the <b>Group II</b> discipline level to a <b>Group I</b>.</p>	<p>Director Howard, after reviewing all evidence, determined that sufficient evidence existed to support a <b>Group I</b> violation and issued a P.O. Williams a <b>non-disciplinary verbal counseling</b>.</p>

Hodges #206's failure to provide service to the complainant when he failed to take a report for a crime.</p> <p>Chief Williams <b>dismissed</b> the allegation, citing that P.O. Hodge asked appropriate questions and was correct in advising the Complainant to return with proof that her identity was stolen.</p> <p>The CPRB voted to appeal this decision to the Safety Director.</p>	<p>Director Howard determined that P.O. Hodges failed to draft a police report as sought by a citizen and issued P.O. Hodges a <b>3-day suspension</b>.</p>
