A minimum coverage of \$200,000 is required:

Bodily Injury:

Property Damage:

\$50,000

Insurance company NAIC number must be included

The Insurance Certificate must also include:

1. City of Cleveland must be "additional insured".

2. City of Cleveland must be "certificate holder".

3. 10 day cancellation (not 30) must be given.

4. The words "endeavor to" or "try to" and "but failure to mail such notice shall impose no obligation or liability upon the company, it's agents or representatives" must be deleted.
