contentions orally or in writing, and present evidence and examine witnesses appearing for or against you. Be advised it is a violation of the Ohio Revised Code, the Cleveland Building Code and the Ohio Building Code to build, alter, or change use or occupancy without first obtaining the

required approval from the City of Cleveland Department of Building and Housing.
